In 2019, the European Union decided to establish a European Labour Authority (ELA). The aim of this new authority is to ensure greater fairness in the European labour market. In view of the widespread problems and abusive practices in some areas of labour mobility, the initiative enjoyed the support of both trade unions and a wide range of political actors. Three years after the decision to establish the ELA, the conference »Trade Union Perspectives on the Establishment of the European Labour Authority (ELA)« will take stock of the work and current mandate of the authority.

How can the ELA contribute to fairer cross-border mobility and the fight against wage and social dumping? How successful were its initial activities and campaigns? How does the interaction between the ELA and the national authorities work? These and other questions will be discussed with stakeholders from politics, administration and trade unions.
